# Student Computer and Internet Agreement Form

Access to computers and the internet is provided for the purposes of educational research and learning. The purpose of this agreement is to provide rules for appropriate use of these facilities. This agreement is to be used in conjunction with the Department of Education's 'Internet acceptable use policy and email acceptable policy' and Gol Gol School's 'Student use of the computer network'.

## Student Agreement:

I understand that the use of computers and access to the internet from Gol Gol Public School must be in support of education research and learning and I agree to the following: -

### Computer Use

- 1 I accept responsibility for all activity under my logon account.
- 2 I will only log on under my username and password and correctly log out at the end of each session.
- 3 I will not share my own password or personal details or attempt to find out or give away another person's password or personal details eg. name, address or phone number.
- 4 I will not log on to any computer with another user's password.
- 5 I will not use valuable computer/internet time on non-educational activities during class time.
- 6 I will not access from a floppy drive, or CD/DVD Rom drive, download, or copy any software, games, music onto the computers or data drive, or for personal use at home, other than those programs provided by the Network Administrator.
- 7 I will not damage computers, computer systems, or networks. This includes unplugging/swapping mice, keyboards, tampering with the system set up or adding or removing hardware or software. Furthermore, if I discover any methods of causing such damage, I will report them to the Principal and I will not demonstrate such methods to others.
- 8 I will respect equipment in all computer areas and will not take or use any equipment without a teacher's permission. Furthermore, I will report any theft I am aware of to the Principal.
- 9 All materials transmitted to or from students can be monitored. All home directories, student folders, and disk drives may only contain school related material and can be viewed by staff.
- 10 Students must not store the following types of files in their home directory, without permission from the teacher:  
Program files (.exe, .com); compressed files (.zip, .arj, .lhz, .tar etc); picture files unless they are required by a subject; obscene material - pictures or text; obscene filenames; insulting material; password-protected files; copyrighted material.
- 11 I give permission to allow the school to publish my work and use photographs of me in line with departmental and school policy.
- 12 I will not use chat lines for personal use and will abide by web services regulations.
- 13 I will not breach copyright laws when using the internet.
